## HCD Multi-Flow Trial in Alberta, Canada

Hydrocarbon Dynamics Limited ("HCD") announces that one of its Canadian distributors has been awarded a one well paid trial in Alberta with a large independent Canadian oil & gas producer. The purpose of the trial is to test HCD technology's ability to remediate and inhibit paraffin deposition afflicting their Cardium formation wells and flowlines.

Paraffin deposition in the Cardium formation has historically proved to be troublesome from a treatment perspective for numerous producers. The field is currently subjected to different chemical control measures in an attempt to alleviate these issues, including mechanical removal such as hot oiling/ hot water washes. Treatment with HCD Multi-Flow is expected to mitigate the paraffin related damage and eliminate the need for ancillary/ mechanical removal techniques.

Our distributor plans to utilise HCD Multi-Flow in two separate tests.

- 1. As a standalone inhibitor.
- 2. As a blend component to 'supercharge' their current wax inhibitor product.

The trial will require approximately \$5,000 worth of HCD product.

Positive results could lead to expansion of the trial and ultimately continuous ongoing treatment business as well as unlock prospects with other producers fighting similar challenges in the region.
